Introduction

The website located at **1clickhosting.net** (this “**Website**”) is the property of Simp11 LLC. 1Click is a brand of Simp11 LLC (referred to herein as “**we**” or forms thereof). We respect your privacy and are committed to protecting it through our compliance with this policy.

This Privacy Policy (this “**Policy**”) describes the types of information we may collect from you or that you may provide, and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This Policy applies to information we collect:

- on this Website; on any other linked website that we control or operate that includes a link to this Policy; in email, text, and other electronic messages between us that originate from or result from your use of the either of the foregoing; through mobile and desktop applications that you download from any of the foregoing (collectively, our “**Properties**”); and
- through services that we provide to you (our “**Services**”);
- when you interact with our advertising and applications on third-party websites and services if those applications or advertising include links to this Policy.

It does not apply to:

- information that we collect offline or through any other means, including on any other website that we operate that does not include a link to this Policy; or
- information collected by any third party that may link to or be accessible from or on our Properties.

Please read this Policy carefully to understand our practices regarding your information and how we will treat it. **If you do not agree with this Policy, your choice is not to use our Properties. By accessing or using any of our Properties, you agree to this Policy.** This Policy may change from time to time (see **Changes to Our Privacy Policy**). Your continued use of any of our Properties after we make changes is deemed to be acceptance of those changes, so please check the Policy periodically for updates.

Children

Our Properties and Services are not intended for children under the age of eighteen (18) years (the “**minimum age**”). No one under the minimum age may provide any information to or on any of our Properties or Services. We do not knowingly collect personal information from children under the minimum age. If you are under the minimum age, do not use or provide any information on or through any of our Properties or Services. If we learn we have collected or

received personal information from a child under the minimum age without verification of parental consent, we will delete that information. If you believe we might have any information from or about a child under the minimum age, please contact us at support@1clickhosting.net

Information We Collect About You and How We Collect It

We may collect several types of information from and about you, including information:

- by which you may be personally identified, such as name, postal address, e-mail address, telephone number, and payment details (“**personal information**”);
- that is about you but individually does not identify you; and/or
- about your internet connection, the equipment you use to access our Properties and Services, and usage details.

We may collect this information:

- directly from you when you provide it to us;
- automatically as you navigate through our Properties; or
- from third parties, for example, our business partners.

Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.

Information You Provide to Us

The information that we collect when you provide it to us may include:

- information that you provide directly through interactions with us, such as by filling in forms to register an account with us or subscribing to any of our Services, and when you report a problem with our Properties;
- records and copies of your correspondence (including email addresses), if you contact us;
- your responses to surveys that we might ask you to complete for research purposes; and
- details of transactions between us, including financial information that may be required before transacting with us.

You also may provide information to be published or displayed (hereinafter, “**posted**”) on public areas of our Properties or transmitted to other users or third parties (collectively, “**User Contributions**”). Your User Contributions are posted on and transmitted to others at your own risk. Although we may limit access to certain pages or you may set certain privacy settings for such information by logging into your account profile, you acknowledge that no security measures are perfect or impenetrable. Additionally, we cannot control the actions of other

people with whom you may choose to share your User Contributions. Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

Information We Collect Through Automatic Data Collection Technologies

We may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, which may include:

- details of your visits to our Properties, including traffic data, location data, logs, and other communication data and the resources that you access and use; and
- information about your computer and internet connection, including your IP address, operating system, and browser type.

We also may use these technologies to collect information about your online activities over time and across third-party websites or other online services (behavioral tracking). The information we collect automatically may include personal information, or we may maintain it or associate it with personal information we collect in other ways or receive from third parties. Such information can help us to improve our Properties and Services, including by enabling us to:

- estimate our audience size and usage patterns;
- store information about your preferences, allowing us to customize our interactions according to your individual interests; and
- recognize you when you return to our Properties.

The technologies we use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Properties. Unless you have adjusted your browser setting so that it will refuse cookies, we may use cookies when you direct your browser to our Properties.
- **Web Beacons.** Our Properties may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that we can use, for example, to count users who have visited those pages or opened an email and for other related statistics (for example, recording the popularity of certain content and verifying system and server integrity).

Information from Third Parties

We may receive information about you from third-party services and organizations. For instance, if you access our Services through a third-party application, such as an app store or a social networking site, we may collect information about you from that third-party application.

Third-Party Use of Cookies and Other Tracking Technologies

Some content or applications, including advertisements, on our Properties may be served by third parties, including advertisers, ad networks and servers, content providers, and application providers. These third parties may use cookies, alone or in conjunction with web beacons or other tracking technologies to collect information about you. The information they collect may be associated with your personal information or they may collect information, including personal information, about your online activities over time and across different websites and other online services. They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

We do not control the tracking technologies of third parties or how they may be used. How We Use Your Information

We may use information that we collect about you or that you provide to us, including any personal information:

- to provide, maintain, and improve our Properties and Services;
- to present content to you;
- to manage your account and provide support;
- to research and analyze your use of, or interest in, our products, services, or content
- to provide you with information, products, or services that you request from us;
- to fulfill any other purpose for which you provide it;
- to carry out our obligations and enforce our rights arising from any transactions or agreements between us, including for billing and collection;
- to notify you about changes to our Properties or any products or services we offer or provide through it;
- to allow you to participate in interactive features through our Properties or Services;
- in any other way that we may describe when you provide the information; or
- for any other purpose with your consent.

We may use the information that we have collected from you to enable us to display advertisements to our advertisers' target audiences. Even though we do not disclose your

Disclosure of Your Information

We may disclose aggregated information about you, and information that does not identify you, without restriction.

We may disclose personal information that we collect or that you provide as described in this Policy:

- to our subsidiaries and affiliates;
- to contractors, service providers, and other third parties that we use to support our business;
- to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information that we hold about you is among the assets transferred;
- to fulfill the purpose for which you provide it; and
- for any other purpose that we disclose when you provide the information or for which you provide your consent.
- **SMS Privacy** — By creating an account with Simpli, you agree that we may send you SMS text messages related to your account, including service updates, system alerts, payment notifications, and other information necessary to operate your account. Message and data rates may apply. Message frequency will vary based on your account activity. You may opt out of receiving these messages at any time by replying “STOP” to any message we send. For assistance, reply “HELP” or contact our support team. SMS opt-in data and consent will not be shared with any third parties, except as required to provide our text messaging services.

We may also disclose your personal information:

- to comply with any court order, law, or legal process, including to respond to any government or regulatory request;
- to enforce or apply our rights and agreements, including for billing and collection purposes; and
- if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of our customers or others, which may include exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Choices About How We Use and Disclose Your Information
